**Special Notes:** All animals crossing state lines must have original health certificates that meet the Oregon Department of Agriculture regulations. **A copy of original must be provided to an OFFF team member upon check in,** and will become the property of OFFF. No animals will be unloaded until inspected by an OFFF check-in team member. Animals must be **sound, healthy and free of external parasites.** The Oregon Flock & Fiber Festival (OFFF) reserves the right to require removal of any animal judged unhealthy.

All goats on premises, whether sale or show, must be listed on entry form and housed in OFFF sanctioned pens. NO EXCEPTIONS.
